Matilda hails from Sierra Leone in West Africa. She fled for her life during the rebel war and left her position as Personal Assistant to the then President of the Republic of Sierra Leone, to relocate to the USA on the invitation of the United States Agency for International Development.



With the gift of preaching, worship and teaching, Matilda has served in ministry for over 15 years. She has declared her return to the United Methodist Church to fulfill her grandfather's legacy, the late Rev. James A. Mackie.

People who know her describe her as a very loyal friend, dedicated and on fire for God. She is also a widely traveled international motivational speaker. Matilda was one of 6 women that received the 2022 African Women in Advocacy trophy in France.

Her mission's ministry, Destiny House, expands to 6 nations. Matilda is a Notary Public for the State of Maryland and the President of the Diaspora International platform.

She graduated from the Harford School for Girls Moyamba, a UMC high school and later pursued Journalism (Mass Communication) and Conflict Resolution.

Matilda received her education from various institutions including: the Institute of Public Administration and Management, University of Sierra Leone, the Nairobi Peace Initiatives in Kenya, Human Rights Commission in Liberia, Christian Leadership at Haggai Institute of South Africa, Omega Christian University and Southern Wesleyan University.

She graduated as a fellow from the Barack Obama Organizing for Action Advocacy school in Chicago and has been a guest on radio and television programs including AFRICA 24 at the Voice of America in DC. Matilda is the author of two books, *Battle for the Goal Post* and *So You Think You Can Pray?* Which can be found on Kindle and Amazon.
